MINUTES

OF THE REGULAR MEETING CLAYTON CITY COUNCIL

TUESDAY, November 5, 2019

- 1. <u>CALL TO ORDER & ROLL CALL</u> The meeting was called to order at 7:00 p.m. by Mayor Catalano in Hoyer Hall, Clayton Community Library, 6125 Clayton Road, Clayton, CA. <u>Councilmembers present</u>: Mayor Catalano, Vice Mayor Pierce, and Councilmembers Diaz, Wan, and Wolfe. <u>Councilmembers absent</u>: None. <u>Staff present</u>: Interim City Manager Joseph Sbranti, City Attorney Mala Subramanian, Community Development Director David Woltering, and City Clerk/HR Manager Janet Calderon.
