of Emergency Under AB 361

#### RECOMMENDATION

Adopt a Resolution of the City Council allowing for video and teleconference meetings as needed during the COVID-19 state of emergency under AB 361.

#### **BACKGROUND**

Last year, the State Legislature passed and Governor Newsom signed AB 361 which continues many of the provisions related to the Brown Act that were in place under Executive Orders, which expired September 30, 2021 that allowed for video and teleconferencing during the state of emergency. Since AB 361 has been signed into law, the City can continue to meet virtually until such time as the Governor declares the State of Emergency due to COVID-19 over and measures to promote social distancing are no longer recommended by the County Health Officer.

On September 20, 2021, February 2, 2022, March 1, 2022, April 15, 2022, June 14, 2022, July 5, 2022, August 9, 2022, September 1, 2022 and October 4, 2022, the Contra Costa County Health Officer issued recommendations for safely holding public meetings and continues to encourage on-line meetings over in-person public meetings if feasible. If in-person meetings occur, the County Health Officer recommends physical distancing of six feet of separation between all attendees to the extent possible. The proposed resolution provides that the City Council and all subsidiary City boards and commissions <u>may</u> choose to hold fully virtual video and teleconference meetings while the state of emergency is still in effect and physical distancing is recommended.

In order to continue to be able to hold video and teleconference meetings <u>as needed for COVID/public-health related reasons</u>, the City Council will need to review and make

# RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CLAYTON ALLOWING FOR VIDEO AND TELECONFERENCE MEETINGS DURING THE COVID-19 STATE OF EMERGENCY UNDER AB 361

**WHEREAS**, on March 4, 2020, the Governor of the State of California proclaimed a State of Emergency for COVID-19;

**WHEREAS**, AB 361 was passed by the State Legislature and signed by Governor Newsom and went into effect immediately and allows the City to continue to meet virtually until such time as the Governor declares the State of Emergency due to COVID-19 over and measures to promote physical distancing are no longer recommended;

WHEREAS, on September 20, 2021, February 2, 2022, March 1, 2022, April 15, 2022, June 14, 2022, July 5, 2022, August 9, 2022, September 1, 2022 and October 4, 2022, the Contra Costa County Health Officer issued recommendations for safely holding public meetings and encourages on-line meetings if feasible and if in person meetings occur then recommends physical distancing of six feet of separation to the extent possible and masking for all attendees;

**WHEREAS**, pursuant to AB 361 the City Council will review the findings required to be made at least every 30 days.

**NOW THEREFORE BE IT RESOLVED** the City Council hereby finds on behalf of itself and all other City legislative bodies: (1) a state of emergency has been proclaimed by the Governor; (2) the state of emergency continues to directly impact the ability of the City's legislative bodies to meet safely in person; and (3) local health officials continue to recommend measures to promote physical distancing.

**BE IT FURTHER RESOLVED** that the City Council and all other City legislative bodies <u>may</u> continue to meet via video and/or teleconference as needed during the COVID-19 emergency.

#### **RECOMMENDATION**

City Council welcome and recognize new local businesses established in Clayton since January 1, 2022.

#### **BACKGROUND**

During the City Council meeting held on August 16, 2022, City staff proposed establishing a program that provides owners of new local businesses the opportunity to attend a City Council meeting and announce the opening of their businesses in the City. Implementing this new program will strengthen the connection between the City Council and businesses by providing a direct line of communication between business owners and the City Council. The program will also provide a platform for owners of new businesses to announce promotional events such as ribbon-cutting ceremonies and to invite City Council members to these events to help spread the news of their services within the community.

#### **DISCUSSION**

From January 1, 2022, to October 20, 2022, the City of Clayton processed and accepted 41 new business license applications, 24 of them consisting of home-based businesses. All new businesses were sent a postcard from the City of Clayton formally inviting them to tonight's City Council meeting. Going forward, at a regular City Council meeting in May and November of each year, owners of new businesses that opened in the preceding six months will be invited to attend the City Council meeting to announce their business.
