Dear Clayton City Council,

Please do NOT approve the Noise Abatement Agreement for Oakhurst Golf Course Maintenance Activities, item 4. b. on the Consent Calendar for the January 21, 2025 City Council Meeting, until it is revised to include the first hole in the category of holes considered closest to adjacent residences.

We have been working with the current Assistant City Manager, Interim Community Development Director, Code Enforcement and Councilmember now Mayor and their predecessors since February of 2024 to get the existing noise abatement agreement between Clayton and Oakhurst Country Club revised. We thank them for their efforts. However, the revised agreement does not include our primary request: Include the first hole in the category of holes being closest to adjacent residences and therefore, subject to certain time parameters and routing of maintenance traffic.

The first hole needs to be considered as part of the residential area. Our neighborhood, Diablo Village, was not developed when the first noise abatement agreement was written, so it was obviously not factored in. Our two-story home in particular is directly across from the first hole of the golf course. All of our bedrooms are at the same elevation and facing the first tee and fairway, so when the maintenance team is working, the noise wakes us up and keeps us up. Such early, loud, frequent maintenance work was not done by previous club owners. It has only become disruptive in the last year.
