Thank you for providing an opportunity to share thoughts regarding the extension of the density bonus approval.

I strongly hope that any project approval extension is denied. **The Olivia project has divided the community of Clayton.**

Mr. Jordan has been granted the approval of his project against much opposition (which include very valid points – most notably the concern for increased traffic, decreased privacy and parking for Stranahan residents, and additional pressure placed on Clayton's infrastructure). I do not think that it is up to our city to provide more time for any part of this controversial project to take place.
