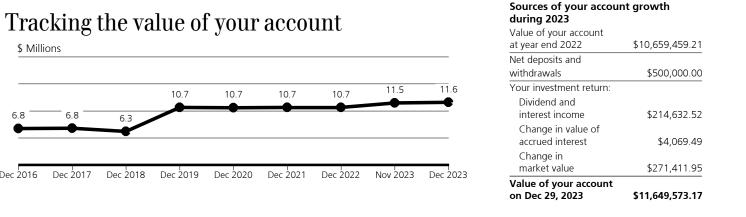

Money market funds

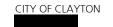

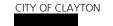

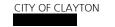
